

Online Course Terms & Conditions

The following Terms and Conditions are entered into by and between You (“**Client**” or “**You**”) and Joyful DVM LLC (“**Company**”, “**we**”, or “**us**”).

Program

The Company agrees to provide you with access to the Online Course entitled, “Vet Life Academy” (“**Program**”). As a condition of participating in the Program, you agree to be bound by and to abide by all policies and procedures set out in this Agreement, including those incorporated by reference.

Terms of Use, Privacy Policy, & Disclaimer

The Company’s Terms of Use, Privacy Policy, and Disclaimer are hereby incorporated by reference into this agreement. Except as modified by this Agreement, each of those agreements and policies shall apply fully to your participation in the Program. In the event of a conflict between any of those policies and this Agreement, this Agreement shall govern.

Nature of The Relationship

Nothing in this Agreement shall be construed to create a partnership, joint venture, employment, or agency relationship. The Company is agreeing only to provide Client with access to the Program, which provides education and information. The information contained in the Program, including any interactions with the instructors, is not intended as, and shall not be understood or construed as, professional advice.

Fees

In consideration of Your access to the Program, you agree to pay the following fees.

An initial payment of \$199 (due immediately) and 11 monthly payments of \$99. Your selected payment method will be automatically charged the following 11 payments on a monthly basis, for a total payment of \$1288. If you opt for monthly payments, you will remain responsible for those payments unless you obtain a refund according to the Program’s Refund Policy set forth below. You may not cancel or avoid these payments except through the Refund Policy. In the event that any payment is not made, the Company shall immediately suspend your access to the Program.

Payment Plan Authorization

If You elect for the payment plan, You hereby authorize the Company to charge your credit card or debit card automatically according to the terms set forth in the Fees section above.

Refund Policy

The Company provides a 30 day paid trial for the Program. That paid trial is governed by the following terms.

We want You to be satisfied with your purchase, so we offer a no-questions asked opportunity to cancel within 30 days of enrollment. You may request cancellation by emailing support@joyfuldvm.com. That email must reference the Product, set out the date of Your purchase, and the email and name associated with the purchase. You are not required to submit any proof that you have completed any work or meet any other requirements.

Upon determining that you are entitled to cancel pursuant to this policy, the Company will promptly issue an instruction to its payment processor to cancel any future payments. You will not receive a refund for the initial payment of \$199.

If you receive a cancellation of any purchase through this 30 day paid trial guarantee, that shall immediately terminate any and all licenses granted you to use the material provided to you under this Agreement and the Company's Terms of Use. You shall immediately cease using the material and shall destroy all copies of the information provided to you, including without limitation: video recordings, audio recordings, forms, template documents, slide shows, membership areas, social media groups limited to paying members, and other resources.

The Program

As part of the Program, the Company shall provide the following to Client.

INCLUDE ALL THAT APPLY:

Access to Course Content- You shall have lifetime access to *content* of Mindset Foundations course, Vet Life Reboot course. In the event that Company intends to discontinue the program, it shall provide clients with NINETY (90) days' notice and the ability to download the resources contained in the course content for the courses listed above.

Access To Program Area – The Company shall maintain a Program Area that may include lessons, forms, worksheets, checklists, and other information. You shall have access to this Program Area for 12 months. In the event that Company intends to close the Program Area, it shall provide clients with NINETY (90) days' notice and the ability to download the resources contained in the Program Area.

Access To Private Forum – The Company shall maintain a Private Forum that You will have access to during the 12 months of the Program. This provides a forum for You to connect with other Program participants and to seek guidance and support. Members of

the Company will seek to interact with Program participants in the group, but the Company does not make any guarantees about participation by any of its employee, founders, or members in the Forum. You are required to abide by any and all rules posted in that Forum. If you fail to abide by those rules, you will forfeit your right to participate in that Forum. In the event you lose your right to participate in the Forum as a result of rules violation, you shall not receive a refund.

Q&A / Instruction Sessions – As a member of the Program, you will have access to weekly group question and answer sessions. You are guaranteed access to a total of 4 such sessions per month. The Company shall provide you with details about how to participate in these question and answer sessions.

Support / Coaching Sessions – As a member of the Program, you will have access to weekly group support / coaching sessions. You are guaranteed access to a total of 4 such sessions per month. The Company shall provide you with details about how to participate in these question and answer sessions.

Bonuses – From time to time, the Company will offer bonuses to individuals who sign up for the Program. You shall be entitled to any bonuses offered to you at the time of registration. Examples of potential bonuses include Lifetime Access and additional courses, programs, services or discounts.

Ownership Of All Intellectual Property

Confidentiality

The Company respects the privacy of its clients and will not disclose any information You provide except as set forth in this Agreement. As a condition of participating in the Program, you hereby agree to respect the privacy of other Program participants and to respect the Company's confidential information.

Specifically, you shall not share any information provided by other Program participants outside of the bounds of the Program unless you receive express written permission from such other participant to share the information. Termination And Access Restriction

Waiver

Force Majeure

The Company shall not be liable or responsible to You, nor be deemed to have defaulted or breached this Agreement, for any failure or delay in fulfilling or performing any term of this Agreement when and to the extent such failure or delay is caused by or results from acts or circumstances beyond the reasonable control of the Company including, without limitation, acts of God, flood, fire, earthquake, explosion, governmental actions, war, invasion, or hostilities (whether war is declared or not), terrorist threats or acts, riot, or other civil unrest, national emergency, revolution, insurrection, epidemic, lock-outs, strikes or other labor disputes (whether or not relating to either party's workforce), or restraints or delays affecting carriers or inability or delay in obtaining supplies of adequate or suitable materials, materials or telecommunication breakdown or power outage.

Effective Date

This Agreement shall commence and be enforceable with respect to each Program participant upon the date that the participant initially registers for the Program.
